Terms and Conditions.

THE SOCIAL GOLF CLUB

Terms &

- To participate in The Social Golf Club Pennant 1
- By entering a team you agree to all the terms and conditions set out in this document.
- You must register your team and pay the \$100 registration fee by Tuesday April 28th, 2015 5pm.
- Each team must consist of a minimum of 4 players and a maximum of 8 players.
- All players registered must hold a valid GOLF link number throughout the duration of the Pennant series.
- Players are required to pay the applicable green fee prior to each Round (Match).
- All Matches must be played in accordance with the Rules of Golf as set out by the R & A, St Andrews Scotland.

2 Nomination of Players for each Match

- Teams must nominate (complete team sheet) and pay the applicable green fee for 4 players per match. Teams are also required to nominate 1 emergency for each Match no later than the Thursday prior to the designated Match at 12pm.
- Only players who were registered by a Team prior to April 28th 2015 can be nominated for a Match.
- If required a team may use the player nominated as the Emergency as a substitute for any of the 4 nominated players for any particular Match. The emergency player shall assume the position in the team order for which the player they are replacing.

Method of Play 3

- Each Match shall consist of 4 contests.
- Each contest shall be played as Handicap Matchplay using each player's applicable Daily Handicap.

Daily Handicaps are calculated as follows;

<u>GA Handicap x Slope</u> = Daily Handicap

- The player with the lowest NETT score shall win the holé.
- Each contest shall be a maximum of 18 holes. If a contest is not decided at the completion of 18 holes the contest shall be "halved" with each team receiving $\frac{1}{2}$ a point.
- All contests shall be played according to the "Stroke/Stableford/Par" index at each course not the Matchplay index.

EXAMPLE

Conditions

A player with a Daily Handicap of 15 shall be entitled to 1 stroke on each hole rated 1 to 15 on the course.

Player A – Daily Handicap 15

Player B – Daily Handicap 10

- On Hole Index 11
- Player A scores 5
- Player B scores 5.
 As Player A is entitled to 1 Stroke he wins the hole with a NETT 4
- The team which wins the most Contests shall be deemed to have won the Match. If the amount of contests won by each team is equal then the Match will be "halved".

• Each team will play in descending Daily Handicap Order for any one Match, and play against the corresponding ranked player in the opposing team.

i.e. – Flight 1 - 4 v 4, 3 v 3. Flight 2 – 2 v 2, 1 v 1

- The player with the lowest Daily Handicap in each Flight shall be responsible for pace of play.
- Each player must register at least 20 minutes prior to their applicable tee time for any Match or the Final.
- The Social Golf Club shall publish the draw for each Contest on it's website on the Friday prior to all Matches.

5 The Draw

- The Draw shall be released on Thursday the 30th of April or when the maximum number of teams registered is reached, whichever occurs first.
- All applicable tee times shall be between 7.30am and 9am on any given round.

6 Points table

- Each Contest shall be worth 1 point. Should the players be tied at the completion of 18 holes each player shall be awarded ½ a point.
- Each Match shall be worth 1 point. Should a team be tied on the Number of Contests won they shall each be awarded ½ a point.
- The points table will be calculated by adding Contest Points and Match Points together. The two teams with the highest points at the completion of 5 Rounds (Matches) shall compete in the final at Victoria Golf Club on Saturday August 22 and 23, 2015.



- 7 Use of carts
- Players are permitted to use motorised carts for all Matches exception the Final. The use of carts is at the Players own expense.

8 Measuring Devices

 Players (in accordance with the Rule of Golf) may use all distance measuring devices during the Matches and Final.

9 Caddies

 Players are permitted the use of a Caddie for all Matches and the Final. However the use of a Professional Golfers as a Caddie is prohibited. All Caddies must be suitable attired in accordance with the dress regulation of the host venue.

10 Tournament Committee

The Tournament Committee shall be employee's of The Social Golf Club. All decisions made will be fnal and no correspondence will be entered in to.
